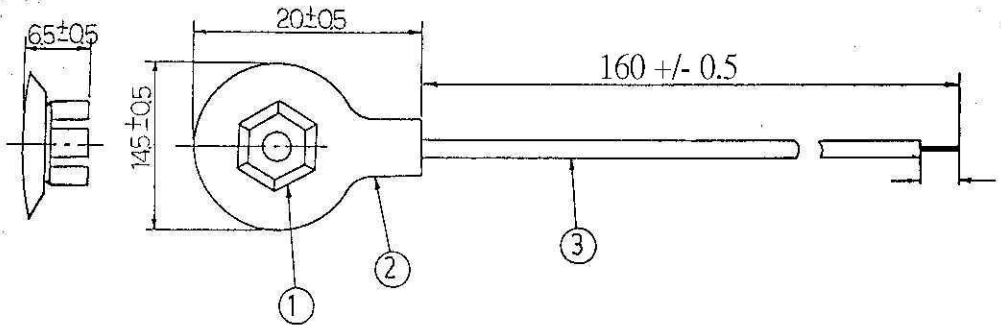

Appendix 3 - RoHS Letter of Compliance
Restriction of the use of certain Hazardous Substances (RoHS)

Samar Enterprises Co Ltd (**Supplier**) certifies to Premier Farnell plc and its subsidiary and associated companies (the **Premier Farnell Group**) that, having made full and careful enquiry:

- (i) all of the materials, components, assemblies, equipment or other products or any parts of such products which it supplies to the Premier Farnell Group and which the Supplier has designated as "RoHS Compliant" by the use of product coding, marking or labelling or by inclusion in a listing of compliant products or similar method; any such method of identification having been clearly identified on the Product Identification Form (the "PIF") which has been agreed and signed by the Supplier and Premier Farnell plc (the Products) are in full compliance with EC directive 2002/95/EC (the **RoHS Directive**), EC directive 76/769/EEC (Restrictions on the marketing and use of certain dangerous substances and preparations), as amended and the national or regional legislation of member states within the European Community implementing such directives (the **Applicable Legislation**); and
- (ii) EITHER the maximum concentration values by weight in homogenous materials for the substances referred to in Article 4(1) of the RoHS Directive that are contained in the Products do not exceed the maximum concentration values of 0.1% in respect of lead, mercury, hexavalent chromium, polybrominated biphenyls and polybrominated diphenyl ethers and 0.01% in respect of cadmium OR the use of such substances at higher concentrations is exempt under the Annex to the RoHS Directive (in which case the Supplier will identify clearly each relevant product and the exemption that applies to it) .

The Supplier confirms that this certificate will apply to all future supplies of the Products to the Premier Farnell Group unless the Supplier informs the relevant member of the Premier Farnell Group in writing at the time of order of any non-compliant Products. The Supplier will inform the Premier Farnell Group immediately that it becomes aware that any applicable exemption is being amended or withdrawn.

Samar Enterprises Co Ltd confirms that Premier Farnell plc is entitled to rely on this certificate for the purpose of providing information to its customers on the compliance of products supplied by Samar Enterprises Co Ltd with the Applicable Legislation and to provide copies of this certificate to its customers and to authorities involved in the monitoring or enforcement of the Applicable Legislation.
