


## Standard Bins for LC503FPG1-15P-A3 ( $I_F = 20 \text{ mA}$ )





#### Important Notes:







REVERSE VOLTAGE.












#### **Mechanical Dimensions**

An epoxy meniscus may extend about 1.5 mm down the leads.

Burr around bottom of epoxy may be 0.5 mm max.


